The Eaton Bray Neighbourhood Plan Questionnaire Summary for Steering Group meeting on 04.10 2017

Background

Based on various questionnaires adopted by other villages a sub-team of the Steering Group prepared a framework for discussion for the full Steering Group meeting on 20 July. It took a couple of hours to prepare a draft questionnaire and this was circulated to the full Steering Group (SG) for their opinions. Final draft was agreed and printed and delivered to all households in Eaton Bray about a week later. Post boxes for the completed questionnaires to be deposited were placed in the Edlesborough Post Office Village Shop (EPO) and the Eaton Bray Village store (EBS).

Six waterproof A3 posters were prepared and placed around the village and two large banners were strategically positioned in prominent positions to advertise the two drop in sessions.

14th August 6.30 pm – 9.00 pm 1st drop in session (DS1) at the Coffee Tavern. Approximately 130 attended and post-it papers were filled in as well as questionnaires.

An interim preliminary analysis of 205 questionnaires was presented to the SG meeting on $21^{\rm st}$ August, together with a draft spreadsheet. The members of the SG decided on more advertising and to send another flyer reminding villagers of the $2^{\rm nd}$ drop in session and one more questionnaire to all households. This task was carried out in early September.

The SG agreed that all the written comments from the questionnaires should be collated and analysed for the SG to review after the second drop in session.

16th September 9.30 am – 12.00 midday 2nd drop in session at the Coffee Tavern

In total 340 questionnaires were received for analysis from the boxes in the shops, drop in sessions and 4 via the Parish Clerk last week.

All the results have been summarised into the Questionnaire spreadsheet and the Comments spreadsheet and a full check for accuracy of the preliminary analyses of the first 205 questionnaires proved the analysis to be accurate.

After all 340 questionnaires had been entered into the spreadsheet a 10% audit of all the results was performed by a second person to check for transcription errors and check that the 'Comments' as documented reflected those on the hardcopy questionnaires. This audit of the data entry into the Questionnaire spreadsheet proved the entry to be accurate and the comments in this spreadsheet matched those written in the comment boxes of the questionnaires.

Report of the responses to the Eaton Bray Neighbourhood Plan Questionnaire Results and Analyses

Half of the villagers (50.3%) who responded to the questionnaire were in the 65 + age group* Approximately a quarter (23.5%) of the responders came from the 55 - 64 age group

About 13% who responded to the questionnaire were from the 45 – 54 age range

6.5% of the responders were from the 35-44 age group

3.2% were in the 25 – 34 age group

2.6% who completed the questionnaires were aged between 16 - 24 years

8 (2.4%) were of unknown age

98.5 % of the responders are residents of Eaton Bray; 1.5% unknown result.

7.1% of the responders work in Eaton Bray.

39.7% of the responders provided their name and 58.8% their postcode

*Demographics of Eaton Bray: 24% of the village are 65 years +; 60% are in the 16 – 64 age group; 16% < 16 years. 1170 dwellings (2015); population 4,300 residents in 2013; 80% home ownership with 11% socially rented and 9% privately rented in 2011 (Refer to: Eaton Bray Ward Profile August 2015 published by CBC)

Q1 What do you like about living or working in Eaton Bray?

LIKES in order of popularity were:

"Easy access to countryside" 91.5%

"Rural atmosphere and open views" 88.8%

"The village is surrounded by Green Belt" 86.8%

Public green spaces eg The Green" 84.1%

"Peace and Tranquility" 82.4%

"Village identity" 74.1%

The above answers reflect how much these characteristics are greatly valued by most of the residents of the village who answered the questionnaire. Many have expanded the above responses with their views in the comments boxes ie. they want EB to stay a village and not become a town and not to be further or over developed.

Relatively less liked were:

"Sports facilities and public recreational spaces" 43.5%

"allotments" 41%

"Range of places of worship" 37.9%

These results possibly reflect the level of satisfaction, relevance or importance the responders place on the above activities in their personal lives.

Q2 What do you dislike about living or working in Eaton Bray?

60.6% responders to the question were discontented with the "Limited public transport"

50% did not like the "Poor or variable mobile signal"

39.4% were unhappy about "Flooding and Drainage" in Eaton Bray

The "Loss of Orchards" was disliked by 40% which possibly related to new development where the orchards used to be; the orchards representing an important part of the history of Eaton Bray. 25% did not like the 'Lack of safe cycle routes' and the 'Lack of a care facility' in the village. The lowest level of dislike was regarding "Light pollution from street lighting" being 11.2%.

Q3 Would you support a Community Energy Scheme Approach in Eaton Bray?

Approximately 30% of residents did not respond to this question at all. About ¾ of the non-responders were in the 65+ age bracket. One reason for the reduced response could be that there was insufficient information readily available to have the knowledge to compare these technologies, although, for those who have a computer the information is on the net.

Solar panels (many commented "not farms") were the most popular with 49% supporting this energy scheme. Electric car charging points were the next most supported with 34.7% ticking this as a potential facility. Heat pumps, biomass, anaerobic digestion and wind turbines scored 16-17%. However, there were many who put "NO" or "None of these" to Q3. There were strong feelings on both sides as indicated in the comments boxes. An analysis of the comments is provided in the appendix at the end of the report.

Q4 If you consider traffic an issue in the village which solutions do you favour?

Good response and strong feelings as evidenced in the comments, summarized in the appendix.

Villagers are thoroughly fed up with the high speed of the traffic going through the village streets and the "Introducing a 20mph speed limit" met with 56% ticks which was the highest % answers achieved for Q4

"Mobile police camera (on occasions)" was favoured by 52% followed by "Traffic calming measures" with 48% and "Speed watch" 39%.

28.5% wanted "Cycling routes around the village" and 19% "Better signage for walkers".

Some of the above comments are for the Parish Council to take up and may not be possible to address in a NP.

Q5 What matters to you when considering any future housing in Eaton Bray?

When considering any future housing in Eaton Bray "Protection of the Green Belt" mattered most to residents as evidenced by the fact that 88.2% ticked this and it was by far the highest % result in this section.

"The Eaton Bray Conservation area" mattered to 69.7% of those who responded.

There was a strong indication (67.4%) for "Off road parking" when considering any future housing

"Additional infrastructure" mattered as evidenced by 55.3% responders ticking this question.

"Density of housing" and "Design of house' mattered to half the responders

"Housing for elderly downsizing" appealed to 46.5%

"starter homes" mattered to 41.2%

"infill / extension of existing footprint" mattered to 35.3%

29.1% ticked "Affordable housing"

26.8 % voted for "A care/nursing home"

16.8% ticked 'Executive homes &/or 2-3 bed houses" but several people crossed out the exec homes Social housing and Flats found favour with only 10% and 5% respondents respectively.

Conclusion

Aside from traffic and transport issues, the overall conclusion of the survey was to protect the green belt and preserve Eaton Bray as a village without more large housing developments. Specifically lacking in support was social housing, flats and executive houses.

Most comments indicate that the volume and speed of traffic is a significant issue. Interestingly though 11 respondents specifically stated traffic is NOT an issue and 7 are strongly ooposed to a 20 mph limit - very much a minority view, as 56% of all respondents indicated they are in favour of a 20mph speed limit. With respect to traffic calming 10 comments were anti speed humps, but 2 were specifically in favour. 33 comments were in favour of restricting parking on the High Street even though this is a "natural" traffic calming measure.
