Majority agreed. It was then proposed that General Purpose Working Group look at the amended agreements to go through and put forward recommendations to March Parish Council Meeting. All agreed.

(4) Highways Matters:

- (4.1) <u>HGV Limit</u>: Cllr. Tomkins confirmed that CBC has approved the plans put forward for restrictions to HGV's through Eaton Bray and Totternhoe. Awaiting confirmation from Bucks County Council for road signage at road entrance points.
- (4.2.) <u>Speedwatch</u>: Additional speedwatch training sessions are being carried out and the unit is now available for use.
- (5) <u>CBC Call for Sites</u>: Councillors discussed land options within the parish and it was proposed that the PC do not reply to the communication at this time. Majority agreed.
- (6) Village Hall Representative: No items to report.
- (7) <u>Car Parking Issues</u>: It has been brought to the council's attention that a number of cars are being parked in such a way to obstruct public footpath pedestrian access. It was proposed the Clerk remind residents/car users that it is an offence to block/obstruct the public footpath. All agreed.
- (8) <u>Future events for Eaton Bray</u>: Cllr. Spicer proposed the council look into putting together events for the parish, i.e. May Day etc., council recommended Cllr. Spicer/Simkins to put forward details/costs to present to the council for further discussion. All agreed.

- (1) Chairman's Correspondence:
 - (1.1) Letter from Edlesoborough Surgery regarding potential developments in Edlesborough/Eaton Bray and the impact on the infrastructure; read to Councillors.
 - (1.2) Letter from Building Contractors regarding the condition of the bus stop at Three Corners read to councillors; it was proposed Clerk write to the two adjacent properties for permission to enter land to allow contractors to be able to obtain a more details report on condition and cost for repair. All agreed.
 - (1.3) Letter received from tree surgeon regarding trees situated in the landscape buffer, Mill End Close. It was proposed that the council accept the quotation with the provision that the tree surgeon ensures that the tree stump is killed to alleviate any potential regrowth. All agreed.
 - (1.4) Letter received from tree surgeon regarding trees recently cut by the adjacent land owner. The report stated that from their point of view not enough foliage was cut back and recommended further work. Clerk report findings to land owner. Agreed.

(2) Clerk's Report:

- (2.1) Read/circulation file handed out to all Councillors.
- (2.2) The Clerk reminded councillors that the PC is fully entitled to inform residents of matters affecting the parish and PC's decision, but need to ensure the PC does not encourage residents to follow the decision of the council. Matter noted.
- (2.3) Defibrillator update: the Clerk has collected the equipment, which is current stored in the Council's office. The Clerk will go through all the paperwork and contact relevant affected parties before actioning further.
- (3) <u>Coffee Tavern/Cottage</u>: All curtain rails on the ground floor have been replaced; the CTT are now looking into replacing the top floor rails, some of which are broken.
- (4) <u>Cemetery</u>: A small wall inside the cemetery has fallen down, it has no use, it was recommended the Clerk organise for the rubble to be removed. Agreed. It was brought to the PC's attention additional land requirements, if the council are having no acceptable outcome from other potential land it was recommended the Clerk contact CBC to find out the options for using a separate new site for a cemetery. Matter to be brought forward at June PC Meeting. All agreed.
